

4. राज्य सरकार द्वारा समय-समय पर बाल वाहिनी के क्रम में जारी किए गये दिशा-निर्देश की अक्षरशः पालना की जावेगी।
5. विद्यालय/संस्था द्वारा भारत सरकार व राजस्थान सरकार द्वारा शिक्षा का अधिकार अधिनियम 2009 के अनुसरण में समय-समय पर जारी दिशा निर्देशों/नियमों की अक्षरशः पालना की जाएगी।
6. विद्यालय/संस्था परिसर में मोबाइल टॉवर स्थापित नहीं करेगा।

9. विद्यालय में दिव्यांग जनों के लिए रैम्प एवं अन्य आवश्यक सुविधाएं उपलब्ध करवायी जावेगी।
10. भारत सरकार/राज्य सरकार द्वारा समय-समय पर जारी दिशा निर्देशों की पालना की जावेगी।
11. भारत सरकार/राज्य सरकार द्वारा आवश्यकता होने पर विद्यालय भवन का अधिग्रहण/उपयोग राजकीय कार्य के लिए किया जा सकेगा।

उपरोक्त शर्तों की पालना नहीं किए जाने की स्थिति में विभाग द्वारा राजस्थान गैर सरकारी शैक्षिक संस्था अधिनियम -1989 एवं नियम 1993 के तहत विद्यालय के विरुद्ध कार्यवाही करते हुए विद्यालय को जारी अनापत्ति प्रमाण पत्र रद्द कर दिया जायेगा जिसके परिणामस्वरूप उक्त संस्था राज्य में विद्यालय का संचालन नहीं कर सकेगी।


